Legislative Update

- Lt. Governor Appoints Sen. Joan Huffman (R-Houston) Chair of Senate Finance
- Interim Charges:
 - House interim charge recommendations filed November 22nd
 - Senate interim charge recommendations due March 4th
 - Release of charges and meetings expected after primary
- November 2021 election:
 - HD 10 - Brian Harrison (R-Midlothian defeated former Rep. John Wray (R-Waxahachie).
 - HD 118 - *John Lujan (R-San Antonio) defeated Frank Ramirez (D-San Antonio), flipping the seat.*
 - HD 31 - Rep. Ryan Guillen (Laredo) switched parties to Republican.
- **Redistricting:**
 - New maps for House and Senate
 - Maintains GOP majority; possibly adds seats
 - Texas gained two congressional seats
 - U.S. Department of Justice filed suit against Texas

ELECTIONS 2022

- All statewide offices are up for re-election

Key Dates:

- Filing deadline - December 2021
- Primary – March 3rd
- General Election – November 8th

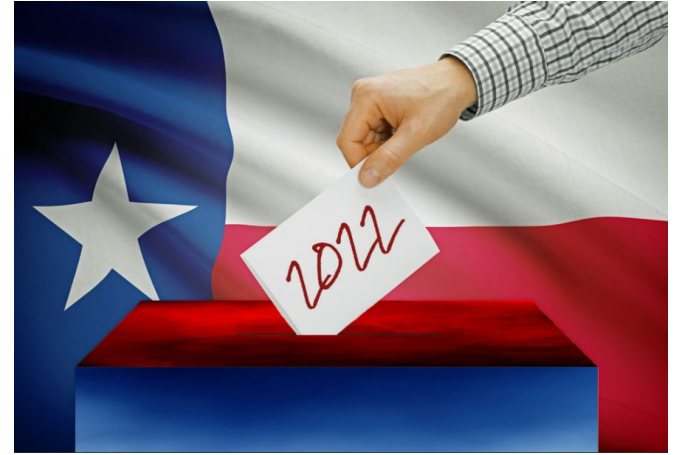
- Texas House: *25 members are not returning*
- Texas Senate: *5 members are not returning*
- Texas could see as many as seven new senators and 30+ new representatives

 - Collier (D)
- *Attorney General:*
 - Paxton, Bush, Guzman, Gohmert (*Republicans*)
- *Agriculture Commissioner:*
 - Miller, White (*Republicans*)
- *General Land Office:*
 - Buckingham (R)
- *Railroad Commissioner:*
 - Incumbent Christian has host of challengers for primary

- TCA Board Meeting – February 6th to discuss legislative priorities:
 - Retainage lien survival (86RHB2024; 87RHB1679)
 - Documents incorporated by reference (86RHB2268)
 - Recycling material local mandates and fees?
 - Criminal history reviews for school contracts.
 - Public land/Private project bond requirements (87R HB 1477/SB 1014)
- Interim Committees hearings – Summer through Fall

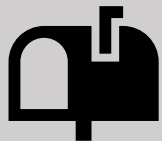
